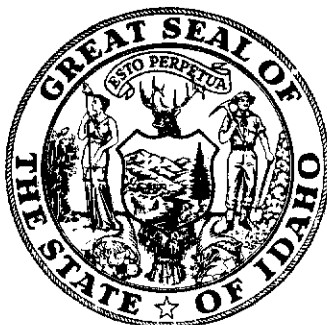

The name of the corporation shall be PRECISION CONSTRUCTION, INC.

*ARTICLE 2*

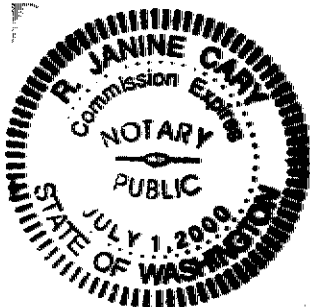
