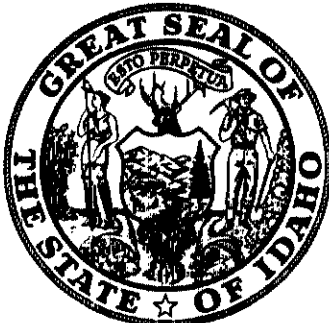

The undersigned, acting as incorporator of a corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation;

1. **NAME**: The name of the corporation is Palisades Park Owners Association, Inc.
2. **NON-PROFIT**: This is a non-profit corporation.
3. **DURATION**: The period of it's duration is perpetual.
4. **PURPOSES**: The purpose or purposes for which the corporation is organized is to manage the Palisades Park property located in the City of Irwin, Bonneville County, Idaho, and for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
5. **MEMBERSHIP**: This corporation is to have members who shall have those rights set forth in the Corporation's By-Laws and Declaration of Covenants.
