The undersigned incorporators, duly licensed to operate an ambulance service by the Idaho State Department of Health & Welfare, adopt the following Articles of Incorporation pursuant to the Idaho General Business Corporations Act, Idaho Code §30-1-2, et seq:

Article 1. Name. The name of the Corporation is **HEARTLINE AMBULANCE, INC.**

Article 2. Purpose. The purpose of this Corporation is to maintain and operate an ambulance service based out of Kootenai County, Idaho and provide ambulance and emergency medical services when and where requested and provide contract ambulance and transport services in the State of Idaho, State of Washington and elsewhere where ambulance or transport services are authorized or requested.

Article 3. Duration. The duration of the Corporation is perpetual.

Article 4. Stock. The Corporation is authorized to issue 10,000 shares of common stock with no par value.

Article 5. Registered Office and Registered Agent. The address of the Corporation's initial registered office in the State of Idaho is 6055 N. Government Way, #10, Coeur d'Alene, Idaho 83814. The registered agent of the corporation is Martin T. Thurman, Sr.


Article 6. Directors. The number of directors constituting the Board of Directors shall be as specified in the corporate by-laws. The names and addresses of the persons who are to serve as directors until the first annual meeting of directors, or until successors are elected and qualify are:
