ARTICLES OF INCORPORATION OF

The undersigned, duly licensed to practice AM 8 56 architecture in the state of Idaho, desires to form a professional association pursuant to Idaho law for the purpose of rendering architecture services, and adopts the following articles of incorporation for such corporation;

ARTICLE I

The name of the corporation shall be Mark A. Gasenica, P.A.

ARTICLE II

The purpose for which the corporation is formed is to engage in the general practice of architecture.

In connection with the above-mentioned purpose, the corporation shall have the power to invest its funds in real property and securities, to acquire, own, and dispose of real and personal property, and to do all other acts to the extent permitted under Idaho law.

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV
