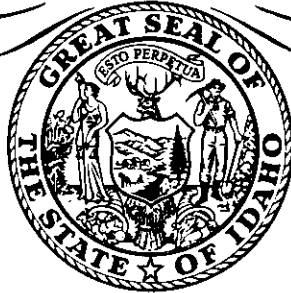

ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

The undersigned, Vern E. Kelsch, President, and Milton A. Romrell, Secretary, of Saving Center, Inc., an Idaho corporation, do hereby certify and respectfully represent as follows:

The the SAVING CENTER, INC. is an Idaho corporation, duly organized and existing under the laws of the State of Idaho, and incorporated on the 5th day of July, 1960; that a meeting of the stockholders of Saving Center, Inc. was duly called by written notice given by the Secretary thereof more than thirty days prior to the date set for such meeting to each stockholder, and that such notice contained a provision of notice that the stockholders would act upon a proposed amendment to the Articles of Incorporation as to the authorized capital stock of the corporation.

That such stockholders meeting of Saving Center, Inc. was held on the 15th day of November, 1973, at Idaho Falls, Idaho, at which time all of the holders of the outstanding shares of the corporation were present in person and acted throughout the entire meeting; that by the affirmative unanimous vote of all of the shareholders of the corporation, there was adopted a resolution amending the Articles of Incorporation as hereafter set forth.

That the resolution adopted by the stockholders amending the Articles of Incorporation is as follows:

RESOLVED, that Article IV of the Articles of Incorporation of Saving Center, Inc., an Idaho corporation, be amended to read as follows:


ARTICLE IV


"The amount of the capital stock of this corporation shall be \$150,000.00 divided into 15,000 shares with

a par value of \$10.00 each, for a total authorized capital stock of \$150,000.00."


