## ARTICLES OF INCORPORATION

(Non-Profit)

The undersigned, in order to form a Non-Profit corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

## **ARTICLE I - NAME**

The Name of this corporation shall be Ledge Creek Horse Park. Corporation

### ARTICLE II – REGISTERED OFFICE ADDRESS

The place in Idaho where the principal office of the corporation is to be located is 1312 Bailey Creek Road, Soda Springs, Idaho 83276 and the registered agent at such address is Carol Call.

## ARTICLE III - MAILING ADDRESS

The mailing address of the corporation shall be 1312 Bailey Creek Road, Soda Springs, Idaho 83276.

### ARTICLE IV - PURPOSE

This corporation is organized exclusively for charitable and educational purposes as specified in Section 501 (c) (3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal revenue Code, or the corresponding section of any future federal tax code.

The purpose of this corporation is:

For erection and maintenance of a public indoor horse riding arena and horse park facility.

## ARTICLE V - EXEMPTION REQUIREMENTS

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

- No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.
- 2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
- 3. Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future tax code, or by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future tax code.

## ARTICLE VI - MEMBERSHIP/BOARD OF DIRECTORS

This corporation shall have members. The eligibility, rights and obligations of the members will be determined by the organization's bylaws.

The management of the affairs of the corporation shall be vested in a board of directors, as defined by the corporation's bylaws. No director shall have any right, title, or interest in or to any property of the corporation.

The number of directors constituting the initial board of directors is six (6); their names and addresses are as follows:

Members of the initial board of directors shall serve until the first annual meeting, at which their

successors will be duly elected and qualified, or removed as provided in the bylaws.

## ARTICLE VII - PERSONAL LIABILITY

No member, officer, or director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers, or directors be subject to the payment of debts or obligations of this corporation.

## ARTICLE VIII - DURATION/DISSOLUTION

The duration of the corporate existence shall be perpetual until dissolution.

Upon the dissolution of the organization, assets of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

## ARTICLE IX - INCORPORATORS
