KNOW ALL MEN BY THESE PRESENTS:

THAT THE INCORPORATOR who is STEVEN MOCK, a citizen of the United States of America, does form a corporation under and pursuant to the laws of the State of Idaho, and does hereby certify as follows:

SECRETARY OF STATE

**FIRST**

The name of the proposed corporation is CAR CADDY CORPORATION.

**SECOND**

The purposes is to engage in any or all lawful business for which corporations may be organized under the Idaho law concerning business for profit corporations and which is permitted by the laws of the State of Idaho.

**THIRD**

This corporation shall have perpetual existence.




