Articles of Incorporation.

At the regularly scheduled Annual Congregational Meeting on June 1, 1909 one lowing amendments to the Articles of Incorporation were voted on and passed by the thirds majority of the members present as stated in Article ix.

ADD TG ARTICLE II

This corporation is organized exclusively for religious, charitable, scientific, lit ry or educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the correction shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code. This organization is not organized for profit, and no part of the net earning shall inure to the benefit of any private shareholder.

A REVISION OF ARTICLE XI

In case of dissolution of the corporation all debts and obligations shall be provided for and all remaining net assets shall be distributed to another organization of similar beliefs and practices and which is an organization which is a non-profit funds foundation or corporation which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code.

The above amendments to the Articles of Incorporation are hereby made a part of the Southwest Christian Church Articles of Incorporation.
