3. The original certificate is amended as follows:

a. Section 6. Section 6 is amended by deleting it entirely and inserting new Section 6 as follows:

- b. Section 7. Section 7 is amended by deleting it entirely and inserting new Section 7 as follows:

The share of the profits or other compensation by way of income which each limited partner shall receive by reason of his contribution or twelve (12) percent of such limited partner's interest.

4. Except as setforth herein, the Limited Partnership Certificate as filed on October 13, 1982 shall remain unamended.
