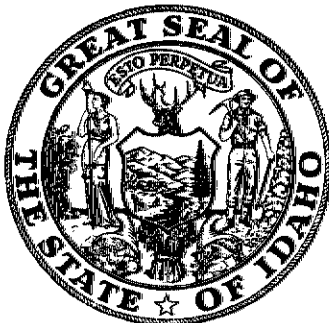

The aggregate number of shares which the corporation shall have the authority to issue is 50,000; the shares shall be the sum of one dollar (\$1.00); the total authorized capital stock of the corporation is the sum of \$50,000(X). The stoce of this corporation shall be nonassessible.
