## Articles of Incorporation of Elmore County Friends for Recovery Council, FIGRETARY OF STATE OF IDAHO

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Idaho, do hereby certify:

Article I: The name of the Corporation shall be Elmore County Friends for Recovery Council, Inc.

Article 2: The place in this state where the principal office of the Corporation is to be located is the City of Mountain Home, Elmore County.

Article 3: The purpose for which the corporation is organized is to provide financial support for treatment, rehabilitation, education and like support for community-based addiction recovery programs, including the Elmore County Drug and DUI Court.

Article 4: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation is organized for the purpose of providing the items described in Article Third hereof.

**Article 9:** The Corporation does have voting members.

Article 10: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third and Fourth hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 11: Upon the dissolution or final liquidation of the corporation, and after the payment or provision for payment of all the liabilities of the corporation, and provision for scholarships in accordance with the bylaws of the corporation, the remaining assets of the corporation will be distributed to such organization or organizations that are then described in IRC §§501(c)(3), 170(c)(2), 2055(a)(2), and 2522(a)(2) and/or to the United States or any state for exclusively public purposes as the board of directors determines.

Article 12: No director or uncompensated officer will be personally liable to the ARTICLES OF INCORPORATION OF ELMORE COUNTY FRIENDS OF RECOVERY COUNCIL, INC.

corporation for monetary damages for conduct as a director or an officer unless the Idaho Nonprofit Corporation Act prohibits eliminating or limiting the liability of a director or an officer for the particular act or omission. No amendment to the Idaho Nonprofit Corporation Act that further limits the acts or omissions for which elimination of liability is permitted will affect the liability of a director or an officer for any act or omission that occurs before the effective date of the amendment.
