

ARTICLES OF INCORPORATION OF

DELLOS LODGE NUMBER 28,

KNIGHTS OF LYTHIAS.

KNOW ALL MEN BY THESE PRESENTS:

That we the undersigned, have this day voluntarily associated ourselves together for the purpose of incorporating under the laws of the State of Idaho, and in pursuance of the purposes for which we have been elected, as hereinafter set forth, a fraternal and benevolent corporation to be known as DELLOS LODGE, NUMBER 28, KNIGHTS OF LYTHIAS.

And we certify, that the objects for which this corporation is formed are for fraternal and benevolent purposes and practises among the members thereof, and to take charge of the building, estate, property and affairs of said corporation;

That there is no capital stock;

That the principal place of business of this corporation shall be in the city of Shoshone, Lincoln county and state of Idaho;

That the term of the incorporation shall be fifty years;

That the number of directors shall be three, who shall have the management of its affairs as aforesaid, and the names of the trustees or directors elected for the first year are:
