ARTICLES OF INCORPORATION

THE CITIZENS RIGHT- OF-WAY COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves for the purpose of forming a Corporation, under the laws of the State of Idaho.

AND WE CERTIFY:

FIRST. That the name of said corporation is THE CITIZENS RIGHT OF WAY COMPANY, LIMITED.

SECOND. That the purposes for which it is formed are: To take over, acquire the complete title to and hold, for the purposes hereinafter named, that certain strip of land known as the Citizens Right of Way, situated in the County of Ada, State of Idaho, and described in that certain Sheriff's deed of conveyance made and executed by J. P. Campbell, Sheriff of the County of Ada to John B. Broadbent, dated the 5th day of May, 1900, and recorded in Book No. 35 of Deeds, commencing at page 1 of the records of said County of Ada, and thereafter conveyed by said John B. Broadbent, the owner of the legal title and William H. Ridenbaugh, Peter Sonna and John Lemp owners of an equitable interest therein. to Nathan Falk, William H. Ridenbaugh and A. J. Glorieux, Trustees, by warranty deed dated the 16th day of June, 1900, and recorded in Book No. 35 of Deeds at page 22 of the records of said County of Ada, and which said Citizens Right of Way has since said last named conveyance been held, owned, managed and controlled by said last named Trustees and the two survivors thereof, to-wit. the said William H. Ridenbaugh and A. J. Glorieur, which said Trustees and the said survivors held said property in trust for railway purposes and have full power to sell, transfer and convey

the same to this corporation and this corporation is formed for the express purpose of carrying into effect the conditions under which said right of way was held by said trustees, and for that purpose it shall have the power and authority to take, hold and maintain the possession of said right of way and every part thereof, and to manage, deal with, control, repair or improve the same, and to institute, carry on and defend suits which may arise or become necessary in carrying out any of these purposes; to make verbal or written leases covering the said property or such portions thereof as may be necessary, for the purpose of raising revenue; to grant, bargain, sell, assign, transfer, convey, remise, release or quit-claim, mortgage, hypothecate or encumber the said right of way, or any part or estate or interest therein upon such terms and conditions as may be deemed advisable, for railroad purposes, when in the judgment of the directors of this corporation, such action will result in sufficient benefit to the city of Boise to justify the same; to permit, under such regulations and conditions as may be deemed proper. the laying of railroad tracks or extending of roads, streets, highways or eldewalks, curbing or pavement over, along and across such right of way, and the laying of gas, water, sewer or other mains, pipes or conduits or the building of roads, passages, subways or other works, under the surface thereof, or the construction of viaducts or elevated roadways over the same, or the building of stations, depots, freight houses or elevators thereon, and in general to permit or cause the construction or erection of any other structure thereon or any other use to be made thereof, which may be desired advantageous; to acquire by gift, purchase or otherwise, any real or personal property, rights or easements, or property of any kind in connection with said right of way, or which may be deemed to enhance its value or he suitable, proper

or convenient for any of the purposes herein contained; to control, manage, expend, disburse or invest any funds belonging to this company and to become the successor in all respects of the said individual trustees and to take over, accept and hold the complete title and possession thereof, and of all and singular the real and personal property of every kind and description which was held by said trustees by virtue of said trust, or to which they were entitled, and in general to do and perform every act and thing which is or may be incidental or conducive to the attainment of the above, or any of the above objects.

THIRD. That the place where its principal business is to be transacted shall be in the City of Boise, County of Ada and State of Idaho.

FOURTH. That the term for which it is to exist is fifty (50) years, from and after the date of its incorporation.

FIFTH. That the number of its Directors shall be three.

SIXTH. That the amount of the capital stock of this corporation shall be Four hundred fifty thousand (\$450,000) dollars divided into four thousand five hundred shares of the par value of One Hundred (\$100) Dollars each.

SEVENTH. That the amount of said capital stock that has been actually subscribed is four hundred fifty thousand Dollars, and the following are the names of the persons by whom the same has been subscribed:
