

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

I

The name of the corporation shall be Cabo Adventures, Inc.

II

The corporation shall exist in perpetuity.

III

The address of the initial registered office of this corporation in the state of Idaho shall be 8353 W. Brookview Drive, Boise, Idaho 83709, and the name of the initial registered agent at that address shall be Cory Chadband.

IV

The purposes of which this corporation is organized shall be and are:

(1) To purchase, lease or otherwise acquire, own, hold, improve, use and otherwise deal in and with real property, or any interest therein, whether located in the United States or any foreign country.
