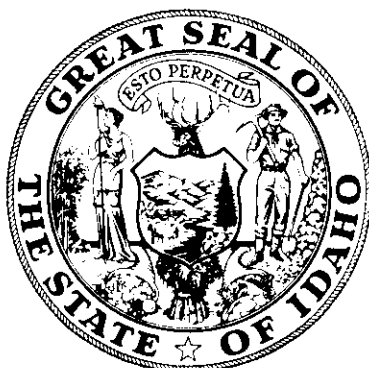

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: We, the undersigned, being three natural persons of full age and citizens of the United States, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, particularly Idaho Code Title 30, Chapter 1, and to that end hereby adopt Articles of Incorporation as follows:

I.

NAME

The name of the corporation is PANORAMA FUEL COMPANY, INC.

II.

PURPOSES

The purposes of the corporation are:

To have and to exercise all of the powers now or hereafter conferred by the laws of the State of Idaho upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereof and supplemental thereof.

To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes, the attainment of any of the objects, the exercise of any of the powers herein set forth, either alone or in conjunction with other corporations, firms, or individuals, and either as principals or agents, and to do every other act or acts, thing or things, incidental or pertinent to or growing out of or connected with the above mentioned objects, purposes or powers.

III.

DURATION

The duration of the corporation is perpetual.

IV.

REGISTERED AGENT AND OFFICE

CAPITALIZATION

The total authorized number of par value shares of the corporation is One Hundred Thousand (100,000) shares of the par value of One Dollar (\$1.00) per share, amounting in the aggregate to One Hundred Thousand Dollars (\$100,000.00)

PREEMPTIVE RIGHTS

Shareholders of this corporation have no preemptive rights to acquire additional shares issued by the corporation.

VII.
