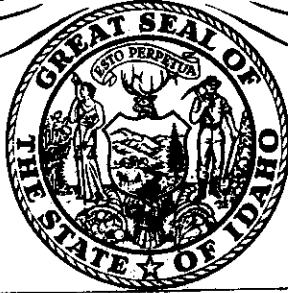

### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

**H. HOFFEL CO.**

was filed in the office of the Secretary of State on the **First** day of **July**, A.D. One Thousand Nine Hundred **Sixty**, and duly recorded on Film No. **112** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at

**Boise**, in the County of **Ada**.

3 (e) To borrow and lend money from any to any person, firm,  
4 association, and to make, take and execute notes, mortgages, bonds,  
5 deeds of trust, or other evidence of indebtedness to secure payment  
6 thereof, or by any other lawful manner or means, and to take and  
7 receive notes, bonds, mortgages, deeds of trust, or any evidence  
8 of indebtedness, for the use and benefit of said corporation, or  
9 otherwise.

10 (f) To own, hold, lease, or sublet, or to conduct on its  
11 own account, or for any person, firm, association or corporation,  
12 all and every kind of merchandise.

13 (g) To build any and all necessary shops, buildings, ware-  
14 houses, and structures at any place, property or convenient, to  
15 carry on any or all of the business of said corporation.

16 (h) To purchase or otherwise acquire and own the corporate,  
17 common, and preferred stock and bonds of any other corporate, and  
18 also to purchase and acquire its own common stock insofar as not  
19 contrary to the laws of the State of Idaho.

20 (i) In addition to the said foregoing powers, also to have  
21 all authority, powers and rights granted by the laws of the State  
22 of Idaho, and particularly Section 30-114 Idaho Code, and any  
23 amendments thereof.

24 (j) In general to transact and do all such matters and  
25 things as are or shall be considered as conducive or incidental to  
26 each and every of the above purposes, and to conduct and carry on  
27 the business for which this corporation is organized alone and/or  
28 with others as co-partners or joint adventurers or otherwise, it  
29 being expressly provided that the foregoing enumeration of specific  
30 powers shall not be held to limit or restrict in any manner the  
31 general powers of the corporation.

1 ARTICLE III

2 The registered office of this corporation and the principal  
3 place for transaction of its business is hereby designated as  
4 Boise, Ada County, Idaho.

5 ARTICLE IV

6 This corporation shall have perpetual existence.

7 ARTICLE V

8 The number of directors of this corporation shall be not  
9 less than three (3) in number.

10 ARTICLE VI

11 The amount of the capital stock of this corporation is  
12 One Hundred Thousand Dollars (\$100,000.00) divided into One Thousand  
13 (1,000) shares of common stock, each of the par value of One Hundred  
14 Dollars (\$100.00) per share; said stock shall be non-assessable.

15 ARTICLE VII

16 The amount of the capital stock actually subscribed is  
17 three (3) shares by the persons whose residences and the amounts  
18 subscribed are herein set forth:


