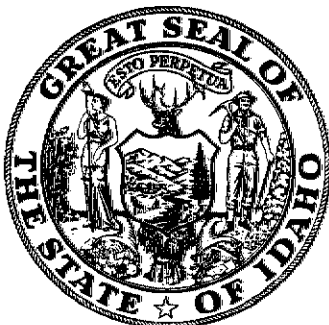

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.


- FIRST: The name of the corporation is 3-D FIRE PROTECTION SALES & SERVICE, INC.

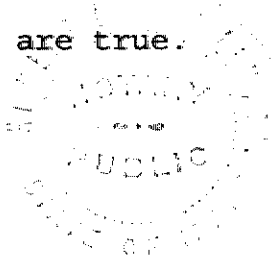


