ARTICLES OF INCORPORATION

0F

CAMAS CREEK IMPROVEMENT ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of Chapter 10, Title 30 of the Idaho Code, and acts amendatory thereof, and supplemental thereto, do hereby certify as follows:

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE "CAMAS CREEK IMPROVEMENT ASSOCIATION, INC."

ARTICLE II

THE PURPOSES AND OBJECTS FOR WHICH THE CORPORATION IS FORMED ARE AS FOLLOWS:

- A. TO FORM AN ASSOCIATION OF MEMBERS WHO OWN WATER RIGHTS
 IN MUD Lake, CAMAS CREEK AND ITS TRIBUTARIES AND WHO OWN LANDS
 BORDERING ON CAMAS CREEK AND ITS TRIBUTARIES.
- B. To CLEAN AND REMOVE OBSTRUCTIONS FROM CAMAS CREEK AND ITS TRIBUTARIES WHICH INTERFERE AND OBSTRUCT THE NATURAL FLOW OF WATER IN CAMAS CREEK AND ITS TRIBUTARIES.
- C. To install head gates and other diversion works on Camas Creek and its tributaries so that the waters of Camas Creek and its tributaries can be lawfully diverted to the legal owners thereof.
- D. To cooperate and assist the Water Master of Water District No. 66 in distributing the waters of Mud Lake and Camas Creek and its tributaries.
- E. THE CORPORATION MAY DO ALL AND EVERYTHING, INCLUDING THE MAKING, THE CARRYING OUT OF CONTRACTS THAT ARE NECESSARY, SUITABLE AND PROPER FOR THE ACCOMPLISHMENT OF ANY OF THE PURPOSES AND OBJECTS OR THE FURTHERANCE OF ANY OF THE POWERS ABOVE SET FORTH.

- F. TO RENT, PURCHASE OR OTHERWISE ACQUIRE MACHINERY AND EQUIPMENT NECESSARY IN CARRYING OUT THE OBJECTS AND PURPOSES ABOVE SET FORTH.
- G. TO MAKE AND ADOPT BYLAWS, RULES AND REGULATIONS FOR THE ADMISSION, SUSPENSION AND EXPULSION OF ITS MEMBERS AND FOR ITS GOVERNMENT, AND FOR THE ELECTION AND APPOINTMENT OF ITS DIRECTORS AND OTHER OFFICERS AND TO DEFINE THEIR DUTIES AND FOR THE SAFEKEEPING AND PROTECTION OF ITS PROPERTY AND FUNDS, AND IN GENERAL TO REGULATE, MANAGE AND PRESERVE ITS PROPERTY AND INTERESTS, AND FROM TIME TO TIME TO ALTER, REPEAL, RESCIND OR VARY SUCH BYLAWS, RULES, REGULATIONS OR ANY OF THEM.
- H. Corporations, associations and co-partnerships, as well as persons may become members and the corporation hereby formed is not organized and shall not be conducted for the purpose directly or indirectly fixing the price or regulating the production of any article of commerce or produce of the soil, or of consumption by the people.

ARTICLE 111

THE CORPORATION IS TO HAVE PERPETUAL EXISTENCE.

ARTICLE IV

The Location and post office address of the registered office of the corporation shall be at Terreton, Jefferson County, Idaho.

ARTICLE V

THE RIGHTS AND INTERESTS OF ALL MEMBERS OF THE CORPORATION
SHALL BE EQUAL, AND NO MEMBER SHALL HAVE OR ACQUIRE A GREATER INTEREST
THEREIN THAN ANY OTHER MEMBER; SAID CORPORATION SHALL ISSUE MEMBERSHIP CERTIFICATES TO EACH MEMBER THEREOF, WHICH CERTIFICATE OF MEMBERSHIP SHALL NOT BE ASSIGNED IN SUCH MANNER THAT THE TRANSFEREE THEREOF
CAN BY SUCH TRANSFER BECOME A MEMBER OF THE ASSOCIATION, EXCEPT BY
RESOLUTION OF THE BOARD OF DIRECTORS AND UNDER SUCH REGULATIONS AS
THE BYLAWS MAY PRESCRIBE; THE NUMBER AND QUALIFICATION OF MEMBERS,
THE TERM AND CONDITIONS OF ADMISSION, FEES FOR ADMISSION AND OTHER
REGULATIONS CONSONANT WITH THE OBJECTS OF THE CORPORATION AND NOT

REPUGNANT TO THE LAW, OF THE STATE OF IDAHO, SHALL BE AS PRESCRIBED BY THE BYLAWS.

ARTICLE IX

THE EXECUTIVE OFFICERS OF THE CORPORATION SHALL BE A PRESIDENT, VICE-DRESIDENT, SECRETARY AND TREASURER; THE OFFICE OF SECRETARY AND TREASURER MAY BE HELD BY THE SAME PERSON. THE CORPORATION MAY HAVE SUCH OTHER OFFICERS AS MAY BE DESIGNATED IN THE BYLAWS. SUCH EXECUTIVE OFFICERS SHALL BE ELECTED BY THE BOARD OF DIRECTORS IMMEDIATELY FOLLOWING THEIR ELECTION AT THE ANNUAL MEETING OF THE MEMBERS.
