CERTIFICATE OF INCREASE OF CAPITAL STOCK OF

We, the undersigned members of the Board of Directors of the TREGO DITCH COMPANY, do hereby certify: That at a regular meeting of the Board of Directors of Trego Ditch Company held at the office of the company by a majority vote of said Board of Directors a regular and special meeting of the stockholders of said corporation was called to be held at the office of the corporation at Riverside, in Bingham County, Idaho, on the 14th day of March, 1927, at 2 o'clock p. m. of said day, for the purpose among other things of voting upon the question of increasing the capital stock of said corporation from its present amount of Sixteen Thousand (\$16,000.00) Dollars, divided into One Hundred Sixty (160) shares of the par value of \$100.00 per share, to Twenty-four Thousand Five Hundred (\$24,500.00) Dollars, divided into Thirty-five Hundred (3500) shares of the par value of Seven (\$7.00) Dollars per share; that personal notice of the time and place of holding said stockholders' meeting and the object thereof, to increase said capital stock as set forth, was given to all persons who were stockholders of said corporation thirty days before the date of holding said meeting, by mailing a copy of such notice to each of said stockholders at his place of residence, and service of said notice was further had by the publication of a notice of the time and place of holding said meeting and the objects thereof as aforesaid, at least once a week in the Idaho Republican, a weekly newspaper published at Blackfoot, Bingham County, Idaho, for six consecutive weeks, a period of more than thirty days, immediately prior to date of meeting, said newspaper being published in the County where the principal place of business of said corporation is located; that a meeting of the stockholders of said corporation was

held pursuant to said notice, at the time and place therein specified and for the purposes therein enumerated and at said meeting 141 $\frac{1}{2}$ shares of the issued stock out of 160 shares issued was represented, the same being more than two-thirds of the issued capital stock of said corporation, said stock so represented amounting to \$14,150.00; that the capital stock of said corporation is \$16,000.00, represented by 160 shares of the par value of \$100 per share, and, thereupon, a resolution was offered authorizing the increase of the capital stock of said corporation, as in said notice and herein provided, from \$16,000 to \$24,500 and from 160 shares of the par value of \$100 per share to 3500 shares of the par value of \$7.00 per share, and the motion made that said resolution be passed and adopted, which motion was duly seconded and after consideration put by the chairman and was carried by a vote of 141 $\frac{1}{2}$ in favor thereof, no vote being cast against said motion; that the vote so taken in favor of said resolution was more than two-thirds of the capital stock of said corporation and more than two-thirds of the capital stock of the corporation voted in favor of increasing the capital stock of said corporation as aforesaid, and the chair announced that said motion was carried.

That five stockholders of the corporation constitute the Board of Directors of said corporation.
