





1 Upon the dissolution or winding up of the corporation, its assets remaining after  
2 payment of, or provision for payment, of all debts and liabilities of this corporation,  
3 shall be distributed to a nonprofit fund, foundation or corporation which is organized  
4 and operated exclusively for charitable purposes and which has established its tax  
5 exempt status under Section 501(c)(3) of the Internal Revenue Code. If this corporation  
6 holds any assets in trust, or a corporation is formed for charitable purposes, such  
7 assets shall be disposed of in such manner as may be directed by decree of the  
8 superior court of the county in which the corporation has its principle office, upon  
9 petition therefore by the Attorney General or by a person concerned in the liquidation,  
10 in a proceeding to which the Attorney General is a party.

11 If this organization holds any events to which members of the general public are  
12 invited to observe or participate in for a fee, the income from the general public, less  
13 a proportional share of the expenses which will not benefit members, will be paid  
14 over to an organization which is exempt from income tax under Section 501(c)(3) of the  
15 Internal Revenue Code on an annual basis.
