





ARTILES OF INCORPORATION OF FORD FEDERATION

93/584 NOV 15 1977.

The name of this Corporation shall be Ford Federation.

II

The purposes for which this corporation is formed are;

- (A) The specific and primary purposes of this organization are social, recreational pleasure and charitable.
- (B) The general purposes and powers are to have and exercise all rights and powers conferred on nonprofit corporations under the laws of California, including the power to contract, rent, buy or sell personal or real property, provided however, that this corporation shall not, except in an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this corporation.

This corporation is organized pursuant to the General Nonprofit Corporation Law of the State of California. This corporation does not contemplate pecuniary gain or profit to the members thereof and it is organized for nonprofit purposes.

	exempt status under Section 501(c)(3) of the Internal Revenue Code. If this corporation
	holds any assets in trust, or a corporation is formed for charitable purposes, such
	assets shall be disposed of in such manner as may be directed by decree of the
	superior court of the county in which the corporation has its principle office, upon
	petition therefore by the Attorney General or by a person concerned in the liquidation,
	in a proceeding to which the Attorney General is a party.
	If this organization holds any events to which members of the general public are
	invited to observe or participate in for a fee, the income from the general public, less
	a proportional share of the expenses which will not benefit members, will be paid
	over to an organization which is exempt from income tax under Section 501(c)(3) of the
	Internal Revenue Code on an annual basis.
