ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, a natural person over the person of twenty-one (21) years, acting as incorporator of Nationwide Mortgage, Inc. under the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME
