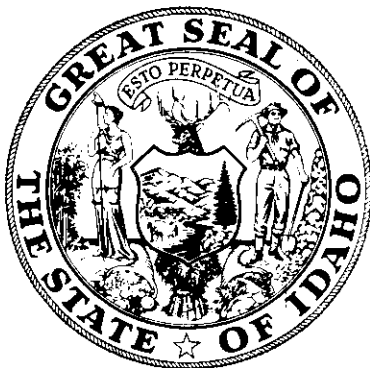

ARTICLES OF AMENDMENT OF IMD, INC.

Pursuant to Idaho Code Section 30-1-61, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is IMD, INC..
2. The following amendments of the Articles of Incorporation were adopted by the full shareholder of the corporation on February 26, 1980, in the manner prescribed by the Idaho Business Corporation Act:

a. Article 4 of the Articles of Incorporation is rescinded.

b. In lieu of said Article 4 there is adopted the following:

ARTICLE 4. The corporation shall have authority to issue 100 shares of capital stock, all of one class, having a par value of \$300.00 per share.

3. The number of shares of the corporation outstanding at the time of adoption was 100; and the number of shares entitled to vote thereon was 100, all of one class, all of which were voted for such amendment, and none of which were voted against said amendment.

4. The manner in which the exchange of issued shares provided for in the amendment shall be effected is as follows:

Upon receipt of Certificate of Amendment from the Secretary of State, the corporation, through its proper officers, shall issue Certificates for Shares or fractional Shares at a rate of .545 new shares in exchange for and in redemption of all shares of the corporation now issued and outstanding.

Such exchange and redemption shall cause a change in the total authorized capital of the corporation from \$5,000.00 to \$30,000.00, and shall result in a change of stated capital of the corporation from \$5,000.00 to \$16,350.00.
