# ARTICLES OF INCORPORATION OF CANYON MULTI-PURPOSE STADIUM, INC.

#### ARTICLE ONE

The name of this corporation is and shall be "CANYON MULTI-PURPOSE STADIUM, INC.", a corporation.

#### ARTICLE TWO

This corporation is a non-profit organization and is formed for charitable purposes and especially for the following:

1. The general nature of the business of this corporation shall be to own, maintain, operate and control a stadium and to conduct in said stadium football games, baseball games, softball games, track and field events, rodeos, fairs, expositions, horse races, 4-H club activities and shows, boxing, wrestling, horse shows, and all types of shows and recreational activities and exhibitions for the general public; to acquire, hold, operate and dispose of any and all privileges, rights, franchises and concessions connected therewith; and to buy, sell, lease, mortgage and exchange any and all real and personal property which may be necessary, advantageous or proper in the conduct of said business.

To foster all of the above activities and to encourage activities connected with such events, and to engage in any such activity as may be deemed desirable or essential to any of the above-enumerated activities, and to do any and all things which may encourage the use of a stadium in connection with said activities.

#### ARTICLE THREE

The principal place of business of this corporation shall be 316 South Tenth Avenue, in Caldwell, Canyon County, Idaho.

#### ARTICLE FOUR

The term of existence of this corporation is and shall be perpetual.

#### ARTICLE FIVE

This corporation does not have, and shall not have, any capital stock, neither shall it issue to its members certificates representing capital stock, and this corporation shall not be operated for a pecuniary profit.

#### ARTICLE SIX

The number of directors of this corporation shall not be less than three (3), which number may be increased at any time in conformity with the By-Laws. The term of office of each director and the manner of election shall be provided for in the By-Laws, and the Board of Directors shall be known as and shall conduct the affairs of this corporation under the designation and style of "Board of Directors."
