

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, DON A. JOHNSON of Spokane, Washington, VIRGINIA JOHNSON, of Spokane, Washington, W. J. CUNNINGHAE, of Spokane, Washington, and LILLIAN CUNNINGHAE, of Spokane, Washington, all of whom are citizens of the United States of America and of the State of Washington, have associated themselves together for the purpose of forming a corporation under the laws of the State of Washington and in pursuance thereof, do hereby sign and acknowledge the following Articles of Incorporation, in triplicate originals and do hereby state as follows:

ARTICLE I.

That the corporate name of this corporation shall be VEND-ALL, INC.

ARTICLE II.

That the purposes for which this Corporation is formed are the following:

- (a). To buy, sell, manufacture, repair, alter and exchange, let or hire, lease and operate any and all types of vending machines and to buy, sell, lease and acquire locations for the same.
- (b). To manufacture, buy sell, deal in and deal with candy, syrup and confections of all kinds and the raw materials from which they are made and the products made therefrom and all like or kindred products; to manufacture and prepare for market and to market from vending machines all types of fruits and vegetables, candy, syrup, confections, soft drinks and dairy products and to carry on any other business which may be conveniently carried on in connection with the corporation's objects.
- (c). To open stores, offices or agencies throughout the United States or elsewhere for the merchandising of any of the products heretofore enumerated.
- (d). To purchase or otherwise acquire and undertake all or any part of the business, property

and liabilities of any persons or company carrying on any kind of business which this corporation is authorized to carry on.

- (e). To enter into partnership or into any arrangement for sharing profits, union of interests, reciprocal concessions, or cooperate with any person or company carrying on or about to carry on any business which this corporation is authorised to carry on or any business or transaction capable of being conducted so as, directly or indirectly, to benefit this corporation.
- (f). To purchase from time to time letters patent of the United States or the right and license to use letters patent connected with any form of vending machines and to conduct amusement enterprises inall the branches pertaining thereto and to buy, sell, acquire, own, exchange or otherwise dispose of and deal in real estate, lands and buildings for any of the purposes herein enumerated.
- (g). To do all and everything necessary, suitable, convenient or proper for the accomplishments of any one of the purposes or attainments of any one or more of the objects herein enumerated or incidental to the powers herein named or which shall at any time appear conductive or expedient for the protection or benefit of the corporation.

ARTICLE III.

That the location and Post Office address of the registered office of this corporation shall be 421 Symons suilding, in the City of Spokane, County of Spokane, State of Washington.

ARTICLE IV.

The capital stock of this corporation shall be divided into 50,000 shares of the par value of \$1.00 each; that said shares shall be non-assessable and shares may be issued by the corporation from time to time for such consideration as may be fixed by the Board of Directors.

ARTICLE V.

That the amount of paid in capital with which this corporation shall begin business is the sum of Five Hundred Dollars (\$500.00).

ANTIGLE VI.

That the number of directors of this corporation shall be

not less than three (3), nor more than five (5); That the number, qualifications, terms of office, manner of election, time and place of meeting and the powers and duties of the directors shall be such as are prescribed by the By-Laws of this Corporation; That the names and Post Office addresses of the first directors who shall hold office and manage the affairs of the corporation for a period of one year after its incorporation are as follows:
