

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are citizens and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho:

AND WE HEREBY CERTIFY:

First. That the name of said corporation shall be, W. R. JONES & COMPANY,

Second. That the purposes for which it is formed are, for the buying and selling of Dry-Goods, Groceries, Boots, Shoes, Clothing, Hats, Caps, Tin-Ware, Hardware, Farm Produce, and all other kinds of personal property.

Third. That the place where the principal business of said corporation is to be transacted is Blackfoot, Bingham County, State of Idaho.

Fourth. That the term for which said corporation is to exist is fifty years, from and after the date of its incorporation.

Fifth. That the number of Directors of said corporation shall be five, and that the names and residences of the Directors, who are appointed for the first year, and to serve until the election and qualification of their successors, are as follows, to wit:

Sixth. That the amount of the Capital Stock of said corporation is twenty-five thousand (25,000) ~~thousand~~ dollars, and the number of shares into which it is divided is two hundred fifty, of the par value of one hundred dollars each.

Seventh. That the amount of said Capital Stock which has been actually subscribed is Ten thousand six hundred (10,600) dollars, and the following are the names of the persons by whom the same has been subscribed, and the amount subscribed by each of them, to wit:
