### CERTIFICATE OF INCORPORATION

I, **IRA H. MASTERS**, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

was filed in the office of the Secretary of State on the **eleventh** day of **February** A. D. One Thousand Nine Hundred **Forty-six** and is duly recorded on Film Roll No. **5** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 29-103 and Sections 29-1001 to 29-1005, inclusive, Idaho Code, Annotated.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Weiser** in the County of **Washington** and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations, as provided in Chapter 10, Title 29, Idaho Code, Annotated.

ARTICLES OF INCORPORATION  
OF  
WEISER GIRL SCOUTS, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, each of whom is a citizen of the United States and of Weiser, Washington County, Idaho, and is over the age of twenty-one (21) years, have this day voluntarily associated ourselves together for the purpose of forming a co-operative association under the laws of the State of Idaho, to-wit: Chapter 10, Title 29, Idaho Code Annotated, and we hereby certify:

I.

That the name of this association is WEISER GIRL SCOUTS, INC.

II.

That the purpose and object for which this corporation is formed is, without pecuniary profit, to promote, conduct, provide for, maintain and carry on any and all kinds of activities for the entertainment, diversion, training and recreation of the members of this corporation, all of whom shall be Girl Scouts of America; and that for that purpose and end to buy, own, hold, acquire, mortgage, hypothecate, convey, transfer, lease, exchange and dispose of real and personal property; to issue certificates of membership to worthy persons to become members of the Girl Scouts organization of America, the rights of all members to be equal.

III.

That said association shall have succession by its corporate name

perpetually.

IV.

That the name and Post Office address of its registered office in the State of Idaho shall be the city of Weiser, Washington County, Idaho.
