### ARTICLES OF AMENDMENT

TO .

MIRACLE WATER OF BOISE, INC.

These Articles of Amendment and the following certificate is hereby made and executed pursuant to Sec. 30-146, I.C. for the purpose of amending the Articles of Incorporation of Miracle Water of Boise, Inc., an Idaho corporation (which corporation was formerly known as Vince's Soft Water, Inc., but the name of which was changed by Articles of Amendment, dated December 21, 1964) and to effect a change of name of said corporation to Diversified Sales of Idaho, Inc.

The undersigned, William D. Cady, President of said corporation, and Beatrice N. Cady, Secretary of said corporation, do hereby respectively certify as follows:

That a meeting of all of the stockholders of Miracle Water of Boise, Inc., an Idaho corporation, was held on the 26th day of January, 1967, at Boise, Idaho, pursuant to call and waiver of notice signed by all of the stockholders and filed in the minute book of the corporation.

That at such meeting, the following resolution was presented and upon motion duly made, seconded and unanimously carried, the same was adopted:

BE IT RESOLVED, that Article I of the Articles of Incorporation of Miracle Water of Boise, Inc., (as such Article has heretofore been amended according to Articles of Amendment, dated December 21, 1964) be amended by deleting the entire first Article and inserting in place thereof, the following:

ARTICLES OF AMENDMENT, P. 1

### "ARTICLE I

The name of the corporation is Diversified Sales of Idaho, Inc."

BE IT FURTHER RESOLVED, That the President and Secretary of the corporation, respectively be, and they are hereby, authorized to prepare a certificate of this resolution and amendment to the Articles of Incorporation of this corporation and to file the same with the Secretary of State for the State of Idaho, and to do all things necessary in order to duly effect the change of name of this corporation in accordance with this resolution.
