

ARTICLES OF INCORPORATION
OF THE

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and WE DO HEREBY CERTIFY:

FIRST

That the name of said corporation is the GEM STATE OIL & PRODUCTS COMPANY.

SECOND

That the purposes for which said corporation is formed, are: to sell, deal in and handle lubricating and farm machine oils and greases of every kind and nature; to buy, sell and handle machinery of all kinds; to deal in automobiles and automobile supplies and accessories, tires and tools; to buy, own, hold, transfer, sell and assign real estate and personal property of every kind and nature; and to do all things necessary or incidental to the objects and purposes aforesaid, or any part thereof.

THIRD.

That the place where its principal business is to be transacted shall be the City of Pocatello, in Bannock County, State of Idaho.

FOURTH.

That the term for which this corporation is to exist is fifty (50) years from and after its incorporation.

FIFTH.

That the capital stock of said corporation shall be Twenty-five Thousand (\$25,000) Dollars, divided into two hundred fifty (250) shares of the par value of One Hundred (\$100.00) Dollars per share; that said stock is and shall remain forever non-assessable, said corporation being a corporation limited under the laws of the State of Idaho.

SIXTH.

That the number of directors shall be three (3), and the names and residences of those appointed for the first year are:
