# SECOND

That the purposes for which said corporation is formed, are: to sell, deal in and handle lubricating and farm machine oils and greases of every kind and nature; to buy, sell and handle machineryof all kinds; to deal in automobiles and automobile supplies and accessories, tires and tools; to buy, own, hold, transfer, sell and assign real estate and personal property of every kind and nature; and to do all things necessary or incidental to the objects and purposes aforesaid, or any part thereof.

#### TH IRD.

That the place where its principal business is to be transacted shall be the City of Pocatello. in Bannock County. State of Idaho.
