KNOW ALL PERSONS BY THESE PRESENTS: That we, the undersigned, being persons of full age, citizens of the United States of America and residents of the State of Idaho, do hereby amend the Articles of Incorporation as follows:

I.

NAME

The name of the corporation is MODIE PARK CONSERVANCY, INC.

II.

AMENDMENT TO ARTICLES

The incorporators hereby amend Section VII to the Articles of Incorporation by substituting the following new Section VII set forth as follows:

In the event of the dissolution of this corporation, or in the event it shall cease to carry out the objects and purposes herein set forth, all the business property and assets of the corporation shall go and be distributed to the City of Lewiston, Idaho, for the limited purpose of the development and maintenance of the Ruth Rowell Modie Wildlife Park. In the event at the time of the dissolution of this corporation, the City of Lewiston, Idaho, has not yet developed the Ruth Rowell Modie Wildlife Park or STATE declines to continue maintenance of said park, the business property and assets of this corporation shall go and be distributed to the purpose of public Jaho Foundation for Parks and Lands for the purpose of public park development within the State of Idaho.

In the event that contributions to the City of Lewiston, Idaho, or the Idaho Foundation for Parks and Lands do not meet Section 170(c)(2) of the Internal Revenue Code, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code), or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the Association is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
