ARTICLES OF INCORPORATION OF GASSER CABIN, INC. A NON-PROFIT CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being citizens of the United States and of lawful age, for the purpose of forming a non-profit corporation pursuant to 30-301 et seq., Idaho Code, and for the purposes expressed herein.

ARTICLE I

do hereby adopt the following Articles of Incorporation:

The name of the corporation is GASSER CABIN, INC., a non-profit corporation.

ARTICLE II

The corporation is a non-profit corporation.

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

The purposes for which the corporation is formed are to hold real property in its name for the use and benefit of the Gasser family.

- A. To do all things necessary to preserve, protect, maintain and enhance the quality of the Gasser family cabins and real property situated near West Yellowstone, Montana.
- B. To have the power to transact and any all lawful business for which such corporations may be incorporated under the laws of the State of Idaho.

ARTICLE V

In the event of the dissolution of the corporation or the winding up of its affairs, the corporation's property shall not be conveyed or distributed to any individual or organization created or operated for profit, but shall be conveyed or distributed only to the members of the Gasser family who are then members of the corporation or to an organization or to organizations created and operated for non-profit purposes as may be selected or designated by the members pursuant to the terms of the By-laws at the time of dissolution.

ARTICLE VI

Except for the initial Board of Directors, whose names are in these Articles of Incorporation, the Board of Directors shall be elected or appointed as provided in the By-laws.

ARTICLE VII

Provisions for the regulations of the internal affairs of the corporation, except as provided in these Articles, shall be determined and fixed by the By-laws as adopted by the Board of Directors.

ARTICLE VIII

Membership may be evidenced by a certificate of membership rather than stock. The voting rights and incidents of membership of all members shall be equal and no member may have or acquire a greater interest therein than any other member. All other provisions regarding membership shall be as provided in the By-laws.

ARTICLE IX

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV.
