*We the undersigned persons, citizens and residents of the State of Idaho, have this day voluntarily associated ourselves together to form a corporation, not for profit, acting as incorporators under the provisions of the Idaho Nonprofit Corporation Act (1995), to adopt the following articles of incorporation:*

*ARTICLE I - NAME*

*The name of the corporation shall be THE ROCK CHURCH INCORPORATED*

*ARTICLE II - PURPOSE*

*This nonprofit corporation is organized and operated exclusively for the religious purposes of a church within the meaning of Section 501(c)(3) of the Internal Revenue Code (Revised April, 1996) of the United States of America.*

#### ARTICLE VI - DISSOLUTION OF ASSETS ON DISSOLUTION

Should the church be dissolved, the funds and property remaining shall be distributed to another legally recognized Christian organization. However, if the named recipient is not then in existence or no longer a qualified distributee, or unwilling or unable to accept the distribution, then the assets of this organization shall be distributed to a fund, foundation, or organization which is organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code.

#### ARTICLE VII - INTERNAL AFFAIRS


The internal affairs of the corporation will be governed in accordance with the Constitution of the Rock Church, ratified by the church elders on the Seventh day of September, 1997.

#### ARTICLE VIII - OTHER ACTIVITIES


Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United State Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

These restated articles are ratified by the directors of the Rock Church on the eighth day of Februray, 1997.






