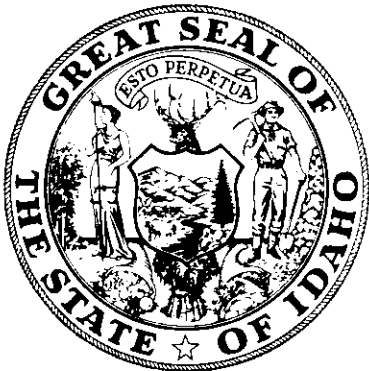

ARTICLES OF AMENDMENT  
OF  
GATEWAY TRAILER CENTER, INC.

The following Articles of Amendment are hereby adopted by  
Gateway Trailer Center, Inc.:

I

Paragraph I of the Articles of Incorporation of Gateway  
Trailer Center, Inc., has previously provided as follows:

"ARTICLE I.

This corporation shall be known as GATEWAY  
TRAILER CENTER, INC., and shall conduct its business  
throughout the State of Idaho and the other United  
States, and in foreign countries."

Said paragraph is amended to provide as follows:

"ARTICLE I.

This corporation shall be known as GATEWAY HOMES  
AND R.V. CENTER, INC."

II

This amendment was adopted by unanimous vote of the share-  
holders of the corporation at a special meeting of the shareholders  
duly called and held on the 16<sup>th</sup> day of July, 1984. All  
corporate stock is common stock. The number of shares outstanding,  
and entitled to vote on the amendment, was 57½. All shares voted  
for the amendment.

All of the issued and outstanding shares in the corporation  
were represented at the meeting and the vote in favor of the amend-  
ment was unanimous.
