

Articles Of Incorporation

The undersigned, who is duly licensed physician to practice medicine in the State of Idaho Medicine in the State of Idaho, desire to form a professional corporation pursuant to Idaho Code §30-1301 et. seq. for the purpose of rendering medical services, in the State of Idaho and adopts the following Articles of incorporation.

ARTICLE ONE NAME

The name of the corporation shall be Healing Arts Women's Clinic, P.A.

ARTICLE TWO PURPOSES AND POWERS

The purpose for which the corporation is formed are as follows:

- 1) To engage in the general practice of medicine and the medical specialty of obstetrics and gynecology as a medical corporation and to operate a medical clinic for the purpose of providing medical care and treatment.
- 2) To promote medical, surgical, and scientific research and knowledge; to furnish related laboratory and clinical services; to invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment and to own real and personal property, to enter into contracts, and to engage in any lawful business necessary for the rendering of such professional services.
- 3) To do everything necessary, proper, or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act and thing incidental thereto that is not forbidden by the laws of the State of Idaho or by the provisions of these articles of incorporation.

The professional purpose of this corporation shall be carried out only through officers, employees, and agents who are duly licensed or otherwise legally qualified in the State of Idaho to render professional medical services.

The duration of the corporation shall be 29 years.
