WE, THE UNDERSIGNED, HEREBY ASSOCIATE OURSELVES WITH THE OBJECT OF FORMING A CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO, AND CERTIFY AS FOLLOWS:
