



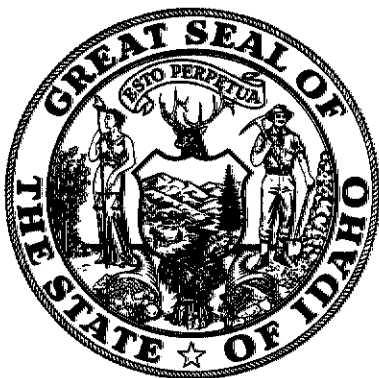
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

WE, THE UNDERSIGNED, HEREBY ASSOCIATE OURSELVES WITH THE OBJECT OF FORMING A CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO, AND CERTIFY AS FOLLOWS:

- 1) THE NAME OF THIS CORPORATION SHALL BE: JOEY AND IVON, INC.
- 2) THE BUSINESS IN WHICH THIS CORPORATION SHALL BE ENGAGED IS
A MEXICAN FOOD RESTAURANT.
- 3) TO CONDUCT ITS BUSINESS, THIS CORPORATION SHALL BE ENDOWED WITH THE FOLLOWING POWERS:
 - A) TO BORROW MONEY AS NECESSARY FOR OPERATIONS,
 - B) TO CONTRACT, BE A PARTNER IN BUSINESS VENTURES, TO ACQUIRE AND DEAL IN ITS OWN STOCK, SHOULD THE NECESSITY ARISE,
 - C) TO ACQUIRE OTHER BUSINESSES, EITHER BY PURCHASE WITH CASH, SECURITIES, NOTES, OR OTHER ASSETS, OR THROUGH MERGER OR OTHER COMBINATION,
 - D) TO DEAL IN, PURCHASE, LEASE, OR SELL PERSONAL PROPERTY AND EQUIPMENT,
 - E) TO MORTGAGE, PURCHASE, LEASE, OR SELL, OR OTHERWISE DEAL IN REAL PROPERTY FOR ALL PURPOSES,
 - F) TO APPLY FOR OR PURCHASE PATENTS, TRADEMARKS, TRADENAMES, OR OTHER INTANGIBLE OBJECTS THAT MAY BE REQUIRED FOR THE ORDINARY CONDUCT OF BUSINESS,
 - G) TO CARRY ON ANY OTHER LAWFUL BUSINESS OR ENGAGE IN ANY OTHER ACTIVITY PERMISSIBLE UNDER THE LAWS OF THE STATE OF IDAHO.

- 4) THE CAPITAL STOCK THAT THIS CORPORATION SHALL BE AUTHORIZED TO ISSUE SHALL BE 1,000 SHARES OF THE PAR VALUE OF \$100 EACH, FOR A TOTAL AMOUNT OF \$100,000.
