

CONSENT TO USE ASSUMED BUSINESS NAME

1. The undersigned, as managing member of Kingdom Property Management, LLC, an Idaho limited liability corporation, hereby consents to the application of Summit View Investments, LLC, an Idaho limited liability corporation, to use the assumed business name "Kingdom Property Management," as of the 22nd day of March, 2013.
