
### CERTIFICATE OF INCORPORATION OF

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, acting as incorporators under the Idaho Business Corporation Act, adopt the following Articles of Incorporation.

I. NAME OF CORPORATION

The name of the corporation is Westside Players, Incorporated.

II. DURATION

The period of it's duration is perpetual.

III. PURPOSE OF CORPORATION

The purpose of purposes of which the corporation is organized are:

The creation, promotion and presentation of theatrical productions and entertainment activities for profit. The promotion of the fine arts. The enjoyment of culinary arts in connection with artistic productions and the transaction of all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

#### IV. STOCK

The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares at the par value of \$1.00 per share.

#### V. CORPORATION REGULATIONS

The internal affairs of Westside Players, Incorporated shall be regulated by such By-Laws as may be provided for the corporation and in addition shall be regulated in accordance with the provisions of the Idaho Business Corporation Act, Section 30-1-23(a).

#### VI. REGISTERED OFFICE




