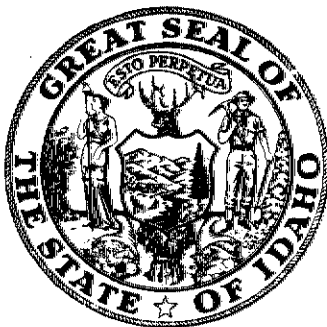

# ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is TOOL TIME, INC.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

**FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares, all of which are to be without par value.

**FIFTH:** The address of the initial registered office of the corporation is 468 Addison Ave. West, Twin Falls, Idaho, and the name of its initial registered agent at such address is Mark L. Goodman.

**SIXTH:** The number of directors constituting the initial board of directors of the corporation is two, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

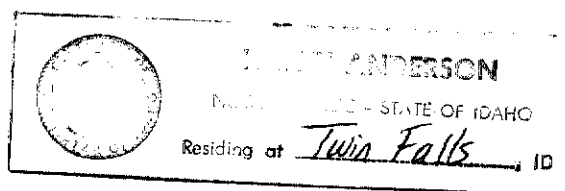
