## ARTICLES OF INCORPORATION

OF

NORTH IDAHO PROPERTIES, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, being residents and citizens of the United States of America, of legal age, do by this agreement associate ourselves together for the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and we do hereby certify as follows:

I.

The name of this corporation shall be North Idaho Properties, Inc.

II.

The purpose of this corporation is to purchase, lease, subdivide, take in exchange, develop and improve, sell, assign, transfer or otherwise acquire lands and interest therein, and to sell, lease, sublease, pledge and otherwise alienate or dispose of; to mortgage or otherwise encumber real property and all or any structures situated thereon; to erect buildings, deal in building materials, to take or hold mortgages or any unpaid balances of the purchase price on any of the lands sold and sell and dispose of mortgages and contracts; to purchase and acquire stock and bonds, debentures and other forms of indebtedness. and to deal in stocks and bonds; to acquire, sell, transfer or alienate stocks and bonds either in this corporation or the stocks and bonds of other corporations, to improve, alter, and manage lands and buildings, to guarantee and otherwise assist in the performance of contracts or mortgages of persons, firms or corporations with whom the corporation may have dealings, and to assume and take over such mortgages and contracts on default, and for such other related purposes therewith, as may be necessary to carry out the purposes thereof, and to do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or any of the objectives, or the furtherance of any of the powers herein set forth, either alone or in association with other corporations, firms or individuals, and to do every act or acts, thing or things pertinent or growing out of, or connected with the objectives or purposes, or any part thereof, provided herein, insofar as the same shall not be inconsistent with the laws of the State of Idaho under which this corporation is formed.

III.

The duration of this corporation shall be perpetual.

IV.

The post office address of the corporation's registered office is P. O. Box 191, Hayden Lake, Kootenai County, Idaho.

V.

The total authorized number of par value shares is 30,000. The aggregate par value of the total authorized number of par value shares is \$300,000.00.

VI.

The stock of this corporation shall be divided into 30,000 shares of common stock, of a par value of \$10.00 each.

VII.
