ARTICLES OF INCORPORATION

OF

CASSIA CHRISTIAN EDUCATION ASSOCIATION, INC.

The, undersigned, acting as incorporators of a non-profit corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation of such corporation.

FIRST

The name of the non-profit corporation is: "Cassia Christian Education Association, Inc."

SECOND

The period of its duration is perpetual.

THIRD

The Corporation is a non-profit corporation.

FOURTH

The purpose or purposes for which the non-profit corporation is organized is to do all acts and exercise all powers, rights and responsibilities available to corporations under the laws of the State of Idaho, including but not limited to charitable, benevolent, religious, civil and educational functions within the community.

FIFTH

The non-profit corporation shall have one class of members known as the Board of Directors. The manner of appointment of the members shall be to allow each church choosing to participate in the non-profit corporation to appoint two members as selected by and approved by the participating church. Each member shall sit on the

Board of Directors and each member shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of the members. The management of the corporation's affairs shall rest in the Board of Directors.
