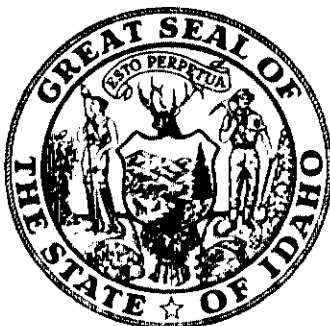

**ARTICLES OF INCORPORATION
OF
B & C WELDING, INC.**

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be **B & C WELDING, INC.**

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The purpose or purposes for which the corporation is organized are to carry on the business of welding and any other lawful activity related to such business, and the transaction of any or all other lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 10,000 with par value of \$1.00 per share. The corporation, if appropriate, may authorize and issue shares of preferred or special classes as provided in Idaho Code §30-1-15.

ARTICLE V

There are no provisions denying preemptive rights.

ARTICLE VI

The mailing address of the initial registered office of the corporation is Route 2, Box 460, Mountain Home, Idaho 83647, and the name of its initial registered agent at such address is Franklin "Bud" L. Corbus. The physical address of the registered agent is Route 2, Box 460, Mountain Home, Idaho 83647.

ARTICLE VII

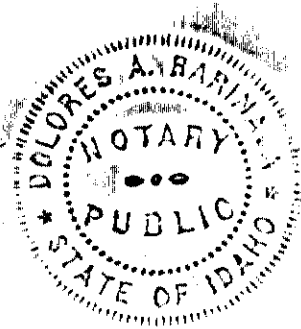
