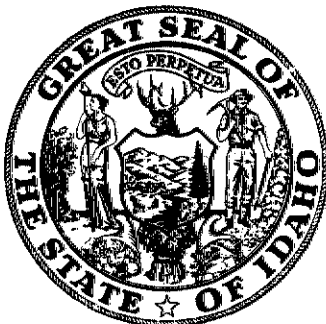

ARTICLES OF INCORPORATION

OF

ROCKY MOUNTAIN DEVELOPMENT, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being of full age and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

Further, we hereby certify the following:

Article I

Name

The name of the Corporation hereby formed shall be "Rocky Mountain Development, Inc."

Article II

PURPOSES AND POWERS

The objects and purposes for which the Corporation is formed and the powers of said corporation are as follows:

A. To develop, manufacture, produce, promote, buy, sell, market, trade and deal in any and all types and kinds of goods, machinery products, furniture, merchandise and personal property of every class and description for and on account of the Corporation or as manufacturer, broker, dealer, factor or agent for others.

B. To buy, sell, mortgage, exchange, lease, let

hold for investment or otherwise, use and operate, real estate of all kinds and description.

C. To enter into, make, perform and carry out contracts of every sort and kind with any person, firm, association, corporation or other legal entity, and to acquire and take over the good will, property, rights, interests, franchises, options, assets and liabilities of any person, firm association, corporation or other legal entity, either wholly or in part, and to pay for the same in cash, stocks or bonds of the corporation or otherwise.

D. To purchase or acquire property, business rights or franchises or any other object in or about its business affairs, to incur debt and to borrow and secure the payment of money in any lawful manner, including the issuance and sale of bonds, debentures, warrants, notes or other evidence of indebtedness.

E. To acquire by purchase, gift or otherwise, shares of its own corporate stock and, if deemed appropriate, to cancel the same or any part thereof, or hold all or any of such stock for resale as treasury stock, or for the purpose of making stock dividends to its shareholders.

F. To restrict the transferability of its outstanding shares of stock to the extent reasonably

necessary to protect the rights of the corporation and its shareholders.

G. To act as surety or creditor in any and all types of transactions, including the power to execute, endorse and deliver contracts and to guarantee the prompt and faithful performance for payment of debts, notes, agreements, contracts and undertakings of any other person, firm, association or corporation, and to act as an accommodation co-maker or guarantor on obligations either as primary or secondary obligor.

H. The several subdivisions contained in this paragraph of objects, purposes and powers of the corporation shall be construed not to limit or restrict in any manner the general powers conferred on business corporations by the laws of the State of Idaho, which powers are hereby expressly claimed by this corporation.

### ARTICLE III

#### DURATION

The corporation shall have perpetual existence.

### ARTICLE IV

#### REGISTERED OFFICE

The registered office of said corporation in the State of Idaho shall be located at Twin Falls, County of Twin Falls, Idaho, and that the post office address of the registered office of said corporation shall be

ARTICLE V

CORPORATE STOCK

The capital stock of this corporation shall be composed entirely of stock of \$10.00 par value, and that the authorized number of shares of 10 par value stock shall be 100000. All of said stock shall be common stock of a single class, and shall be non-assessible.

ARTICLE VI

INCORPORATORS

The amount of capital stock of said corporation which has actually been subscribed is one hundred (100) shares at \$10.00 each, and the following are the names and post offices addresses of each of the incorporators and the number of shares subscribed to by each:

#### ARTICLE VII

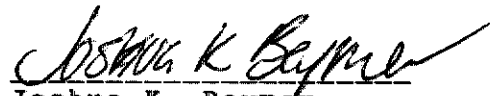

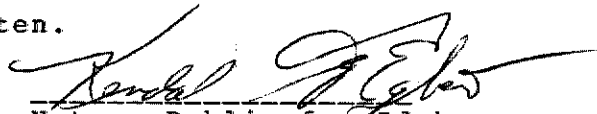
