

ARTICLES OF INCORPORATION OF THE PLUMMER  
FAIR AND RACING ASSOCIATION.

BE IT KNOWN, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

And we hereby certify:

First, That the name of said corporation is the Plummer Fair and Racing Association.

Second. That the purpose for which it is formed is to conduct an amusement park in Plummer, Idaho where entertainments and races may be held and fairs to advance the public interest in the raising of live stock and poultry and in general farming.

Third. That the place where its principal business shall be transacted shall be Plummer, county of Benewah, state of Idaho.

Fourth. That the term for which it is to exist is fifty years from and after the date of its incorporation.

Fifth. That the number of its directors shall be nine(9) and that the names and residences of those who are appointed the first year are as follows:
