ARTICLE I

NAME

The name of this corporation is DAWSON & DAWSON,
LTD.

ARTICLE II

DURATION

This corporation shall have perpetual existence.

ARTICLE III

PURPOSES

The purpose for which this corporation is organized
is the transaction of any or all lawful business for which a
corporation may be incorporated under the Idaho Business
Corporation Act.

ARTICLE IV

CAPITALIZATION

This corporation is authorized to issue only one


