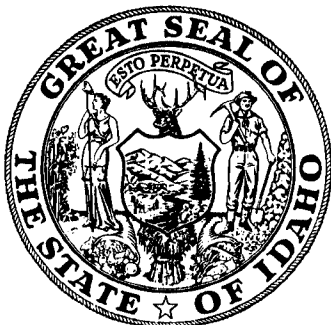

ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, Security Title Company of Idaho, Inc. has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is Security Title Company of Idaho, Inc.

II

The following amendment to the Articles of Incorporation was adopted by the shareholders and directors of the corporation on April 17, 1993, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, that Article III of the Articles of Incorporation of the corporation be amended to read as follows:

III

The aggregate number of shares which the Corporation shall have authority to issue is 50,000 shares of common stock having no par value. Said shares shall be of one class only.

III

The number of shares of the corporation outstanding at the time of such adoption was 10,000, and the number of shares entitled to vote thereon was 10,000.

IV

The number of shares voted for such amendment was 10,000, and the number of shares voted against such amendment was 0.

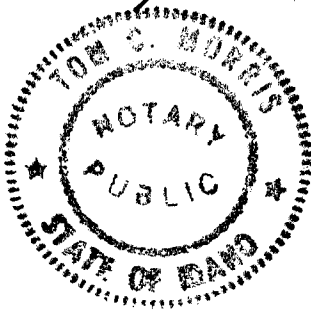
