

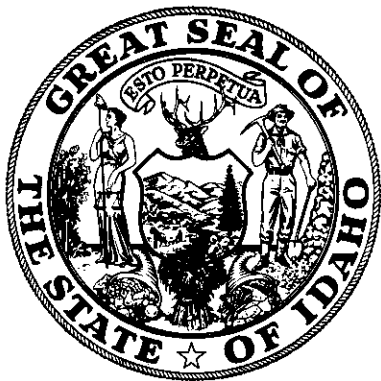
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

UNIVERSAL CONCEPTS, INC.

The undersigned, acting as incorporators, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Universal Concepts, Inc.

ARTICLE II

The purposes for which said corporation is formed are:

A. To acquire, develop and market patents and patented products of every name, nature and description, including manufacturing, franchising and selling such products.

B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation is to have perpetual existence.

ARTICLE IV

The address of the Corporation's initial registered office shall be 5386 Neveso Circle, P. O. Box 2109, Idaho Falls, County of Bonneville, State of Idaho and the name of its initial registered agent at such address is Peter W. Schwarz.

ARTICLE V

The capital stock of the Corporation shall be fifty (50) shares of common stock, without par value. The capital stock of the Corporation shall not be assessable.
