Your letter dated April 22, 2004 requesting approval for use of the company name "Coral Mortgage Bankers Corp." in the state of Idaho, has been received by the Idaho Department of Finance and reviewed by Department staff. From information in your letter, it is our understanding that Coral Mortgage Bankers Corp. is currently licensed as a mortgage banker by the State of Connecticut, and intends to do business in Idaho as a mortgage banker (mortgage lender) and not as a bank or other depository institution.

Section 26-12-1202 of the Idaho Bank Act prohibits any person, other than a national bank, not authorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. The Bank Act does not authorize the Director of the Department of Finance to waive the requirement of this law. Instead, we are offering "no objection" to the use of the word "bankers" in your company's name. Under the circumstances discussed above, we do not believe your company's name is misleading to the public. While the Department does not intend to pursue an action under this statute, it is possible that another agency may do so. However, we believe the likelihood is slight.

I have reviewed the Department's licensing files and find that Coral Bankers Corp. is not licensed under the Idaho Residential Mortgage Practices Act, Idaho Code § 26-3131, et seq. Please be sure that Coral Bankers Corp. has properly qualified under that Act prior to engaging in any mortgage brokering or mortgage lending activities in Idaho.
