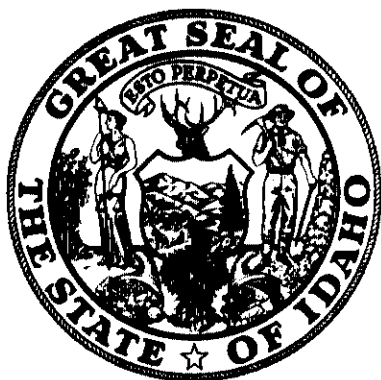

ARTICLES OF INCORPORATION

OF

The Undersigned, acting as Incorporator under the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

NAME

The name of the Corporation is: HOMES XTRA-ORDINAIRE, INC.

DURATION

The period of its duration is perpetual.

PURPOSES
